#### The Propane-Specific Haz-Mat Training

The hazardous materials regulations require that each HM employee be trained and tested within 90 days of employment. In addition, each employer must certify that their employees receive Haz-Mat training every three years.

The regulations require that the training include general awareness and familiarization training, function specific training, security awareness, indepth security, and safety training. **Training must include editorial changes and amendments that have been made to the regulations.**

CDL Hazardous Materials Endorsement does not satisfy the training requirement. Failure to comply with this regulation may result in civil penalties of up to \$27,500, but not less than \$275 per day.
